

Q1 Are you a registered Maine voter?





Q2 Did you see any news stories this summer about "private beach owners" trying to kick people off Maine beaches?





Q3 How familiar are you with year-round economic activities in the intertidal zone, such as clamming, seaweed harvesting and similar commercial pursuits?







Q5 Did you know seaweed harvesters need to get permission from property owners to harvest intertidal seaweed, but that clammers and wormers don't?





Q6 Do you think they should be allowed to harvest seaweed without asking permission just like clammers and wormers do?










